# ABOUT THE CONFERENCE

On June 1, 2022, the International Scientific Conference entitled "The Right to Privacy in the Digital Age - in general terms" will be held at the Institute of Justice in Warsaw. The event will be organized as part of the Central European Professors' Network, coordinated by the University of Miskolc - Central European Academy.

The right to privacy is of particular value for the life of a human being. The protection of private life has been ensured by a number of regulations, including national and international ones. The right to privacy has been placed in the most important documents concerning human rights, but also confirmed by the constitutions of modern states, and included in the national legal orders. The constant development of new technologies and the progressive digitization of subsequent areas of human life have led to the emergence of the information society. The development of IT and ICT solutions, as well as the transfer of individuals' lives to the virtual space, in addition to the benefits associated with it, has also led to the emergence of new threats to the right to privacy. It is necessary to provide adequate guarantees of the right to privacy and legal mechanisms for the legal protection of private life.

The thematic scope of the conference will focus on current issues related to the right to privacy and the dissemination of new technologies, as well as the development of the information society. During the conference proceedings, attention will be paid in particular to the current challenges and problems facing the right to privacy in the era of socio-economic changes that have occurred over recent decades due to the digital revolution. The conference will discuss current issues related to the right to privacy and the development of new technologies, as well as the emergence of the information society. As part of the conference, universal standards regarding the right to privacy will be presented, as well as the problems faced by legislators and the judiciary of Central European countries. Particular attention will be paid to determining the limits of the right to privacy, as well as ensuring effective mechanisms of legal protection that can be introduced into national legal orders. During the conference, the challenges and legal solutions functioning in the countries of Central Europe, including Poland, Hungary, Slovenia, Serbia, Croatia, the Czech Republic and Slovakia will be presented.

During the event, prominent practitioners and scientists specializing in the protection of human rights, but also in other legal branches, will take the floor, which will ensure the extension of the context of the right to privacy to other areas of law, thanks to which the entire spectrum of the problem will be presented.

## IWS INSTITUTE OF JUSTICE IN WARSAW

The Institute of Justice of Warsaw is a state organisational unit subordinate to the Minister of Justice. The Institute performs scientific and research activities in the area of lawmaking and the application, axiology and social operation of law. It also studies the phenomena of crime and social pathology. Institute of Justice conducts studies of lawmaking and the application, axiology and social operation of law as well as the phenomena of crime and social pathology. The Institute disseminates the results of these studies and engages in legal education. Areas of the Institute's research include, in particular: the functioning of legal institutions in the practice of the justice system; the effectiveness of legal protection bodies, legal axiology and the professional ethics of legal professions; the role of jurisprudence and grounds for its performance; the system, organisation and functioning of justice bodies, also against the background of social environment; the causes and conditions of violations of law; the size, structure and dynamics of crime and other pathological phenomena and behaviour; the enforcement of legal sanctions and social rehabilitation of offenders; interdisciplinary and comparative studies of the historical development of institutions of Polish law, including those of Polish law's conformity with the norms and standards of international and EU law. In order to disseminate the results of its studies, the Institute is authorised to organise domestic and international conferences, seminars and engage in publishing and documentation activities. Conducting its research, the Institute of Justice extensively uses scientific studies of case files of judicial and prosecutorial proceedings, reviewing ca. 10,000 files each year. This significant involvement in case file research distinguishes the Institute from other Polish legal research organisations. The Institute also conducts legal and comparative analyses, compiles statistical and economic reports and performs survey studies. More than 400 papers and 70 books have been written by the staff of the Institute's five sections (Section of Criminal Law and Process, Section of Civil Law and Process, Section of Family Law, Section of Economic Studies of the Justice System and Section of Fundamental Rights). As part of its official business, the Institute works with courts, other justice bodies and the National School of Judiciary and Public Prosecution. The Institute engages in international cooperation, taking part in international research programmes implemented by such bodies as the European Commission, Eurostat and the Council of Europe.

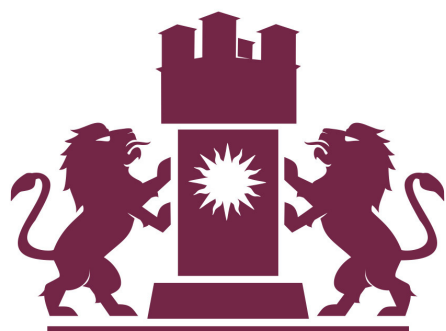

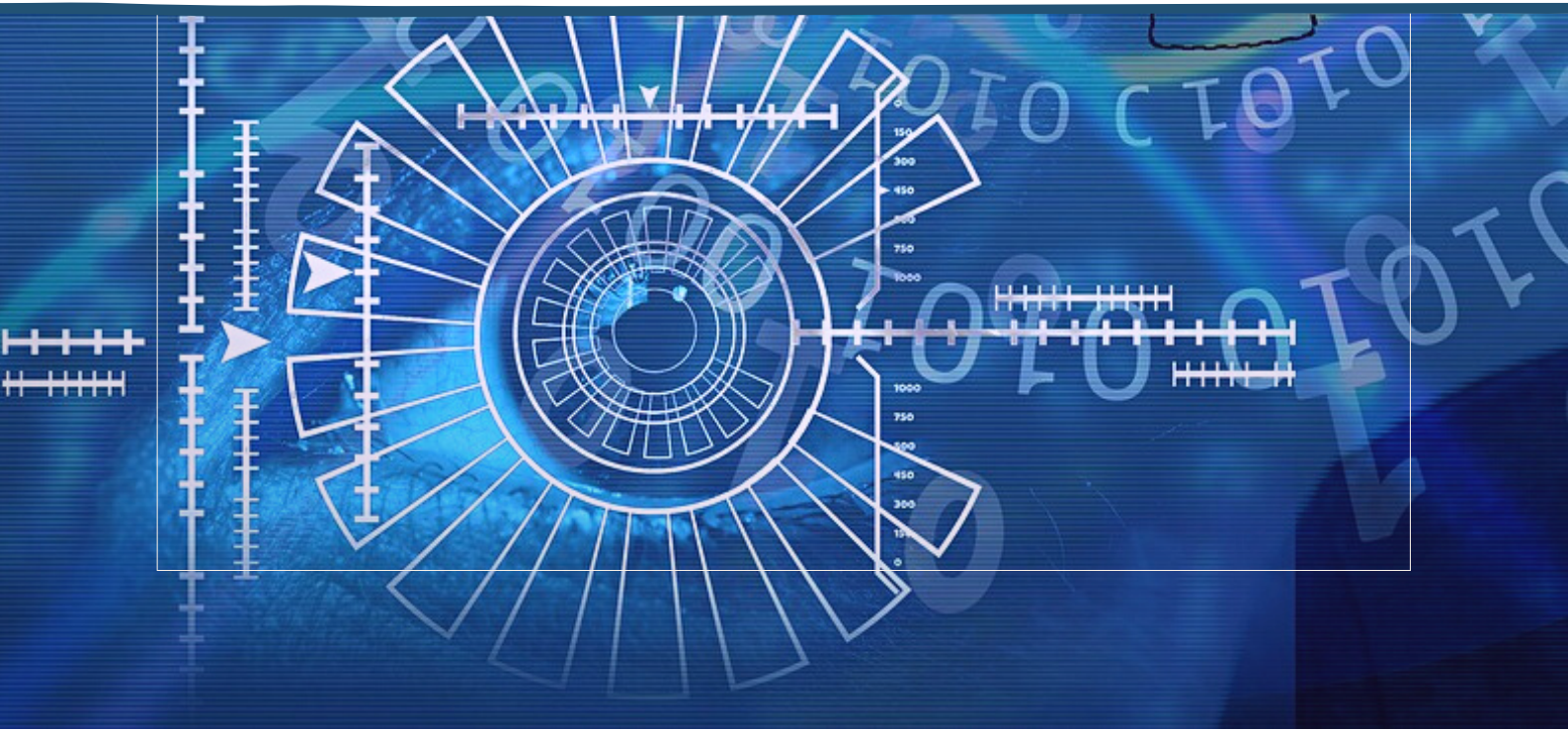

Marcin Romanowski was born on 20 January 1976 in Skrwilno in the Kuyavian-Pomeranian Province of Poland. He holds the title of doctor of legal sciences. During his professional career he was: Director of the Institute of Justice (2016-2019), plenipotentiary of the Minister of Justice for Information Technology and Cybersecurity and for the Justice Fund (2018-2019), expert of the Sejm investigative commission to investigate allegations of corruption cases disclosed in the media during work on the amendment of the Broadcasting Act (2003-2004) and co-author of the report prepared by this commission and, in the years 2005-2007 and 2015-2019, - advisor to the Minister of Justice. He is a graduate of the Rypin High School (1995), a graduate of law at the Faculty of Law and Administration of the Nicolaus Copernicus University in Torun (2000) and of the postgraduate law studies (Magister Legum, LL.M.) at the University of Regensburg, Bavaria (2002).

He was a holder of the Konrad Adenauer Foundation Scholarship at the University of Regensburg (2000 - 2002), Greifswald and Humboldt University in Berlin (2004-2005). In 2008 he defended his doctoral dissertation on "Property in the process of settling accounts with the communist past. Theoretical and legal study on the example of Germany after 1989" at the Cardinal Stefan Wyszyński University (UKSW) in Warsaw. He is assistant professor at the Department of Theory and Philosophy of Law at the Faculty of Law and Administration of the UKSW in Warsaw. The main areas of his research interest are the law of settlements with the past of lawlessness countries, the natural law and the non-positivist concepts of law, the theory of global law and legal anthropology and its applications in the creation and application of law. He is author of publications and scientific studies, also co-author of the monograph "On difficult cases of philosophy of law. Studies in philosophical anthropology" and of "Reprivatisation. Problems of theory and practice".

# PROF. VANJA-IVAN SAVIĆ

## LAWYER AND LEGAL SCHOLAR



Dr Vanja-Ivan Savić is a Croatian lawyer and legal scholar. He graduated from the University of Zagreb Faculty of Law cum laude, where he obtained his First Law Degree. Later he obtained a Master of Science in Law Degree (Company Law and Criminal Law) at the same University. His Ph.D. degree was acquired in Legal Theory and Corporate Criminal Law in 2010 also at the University of Zagreb. His area of expertise includes Legal Theory, Comparative Law, Theory of Law and State, Law and Religion, Corporate Criminal Law and Human Rights. His interests specifically include Law, Religion and State together with Religious Legal Systems as well as Religion and Human Rights in the European Context, specially focusing on the ECHR. Dr. Savić gave lectures connected with Law and Religion and Interfaith Dialogue at many places: gave lectures at BYU London Center (2015), conducted Religion and Rule of Law Program in Myanmar (2017), presented at Tbilisi conference held in Georgia (2017) and also presented at ACLARS conference in 'Law, Religion and Human Flourishing' in Abuja, Nigeria in May 2018, Štip in Northern Macedonia in September 2019 and ACLARS Conference in Durban, South Africa in January 2020. He is one of original signatories to Punta Del Este Declaration on Human Dignity for Everyone Everywhere signed in December 2018 in Uruguay in connection with the Celebration of the 70th Anniversary of the UN General Declaration on Human Rights. Most recently he served as Distinguished Visiting Research Fellow at the University of Adelaide's Research Unit for the Study of Society, Law and Religion and as a Visiting Scholar at the Buffett Center at Northwestern University in the United States, where he conducted the project: "Law as a Tool for Religious Cohabitation: Religious Laws and Laws on Religion in Modern Europe, Middle East and North Africa".

At the same time he was Guest Professor at DePaul University where he taught "Law, Religion and Politics in Europe and the United States" for students of Political Science and Catholic Studies. His work in this respect is connected with the role of law as facilitator of peaceful cohabitation and a tool for achieving peace. He has published articles in Croatian, English, and Vietnamese in Zagreb (Croatia), Hanoi (Vietnam), Cluj-Napoca (Romania), Chicago (DePaul), New York (Columbia), Provo (BYU) and Cambridge (United Kingdom) and has prepared (working) paper in Chicago/Evanston (Northwestern). His textbook on Criminal Liability of Juristic Persons has been published in 2013. Dr. Savić was also Visiting Researcher and Lecturer at the University of Vienna's Platform "Religion and Transformation in Contemporary European Society" and serves as an Associate Professor at the University of Zagreb, Faculty of Law where he works at Legal Theory Department. He teaches 'Legal Theory', 'Religion and Legal Systems of the Middle East and North Africa', 'Human Rights' and 'Croatian Society and Religious Freedoms'. Dr. Savić is co-editor (co-edited with Paul Babie) of the book named 'Law, Religion and Love: Seeking Ecumenical Justice for the Other' (Routledge, 2017). He is active member of 'TRANSCRIM' project where he conducts research about religious prosecution and trafficking from Africa to Europe. He is GDPR Expert in the area of Privacy Law and Religious Organizations. He speaks Croatian/Bosnian/Serbian, English, French and some Spanish, basic Arabic and Hebrew and uses Latin and Cyrillic for scientific purposes.

## DR. ANDRÁS KOLTAY

### *THE PRESIDENT OF THE NATIONAL MEDIA AND INFOCOMMUNICATIONS AUTHORITY OF HUNGARY*

Dr. András Koltay is the research professor of the University of Public Service (Budapest). He is also professor of law at Pázmány Péter Catholic University Faculty of Law and Political Sciences in Budapest, Hungary. He received LL.M. degree in public law at the University College London in 2006, and PhD degree in law at the Pázmány Péter Catholic University in 2008. Between 2018 and 2021, he served as rector of the University of Public Service. He has been the president of the National Media and Infocommunications Authority of Hungary since 2021. His principal research has been concerned with freedom of speech, personality rights and media regulations, but he also deals with other constitutional questions. He is the author of more than 400 publications, and numerous monographs on freedom of speech; in English: *Freedom of Speech – the Unreachable Mirage* (Wolters Kluwer 2013), *The Troubled Relationship between Religions and the State. Freedom of Expression and Freedom of Religion* (Whitlocke 2017) and *New Media and Freedom of Expression* (Hart 2019). He was a speaker in more than 125 conferences in several countries.

# PROF. MATIJA DAMJAN

## ASSISTANT PROFESSOR FOR CIVIL AND COMMERCIAL LAW AT UNIVERSITY OF LJUBLJANA

Dr Matija Damjan, is an Assistant Professor for civil and commercial law at University of Ljubljana, Faculty of Law, and Secretary General of the Institute for Comparative Law attached to the Faculty of Law, where he is also active as a research fellow. He passed the State Examination in Law in 2005, after having worked for two years at the Higher Court in Ljubljana as a judicial trainee. He obtained his PhD at the Faculty of Law, University in Ljubljana in 2007 and has been active in the scientific legal research since then. In his work, he primarily focuses on the areas of civil law, intellectual property law and information society law, and has authored more than thirty scientific articles discussing issues in these fields.



Dr Damjan is also the author or co-author of several scientific monographs and co-author of several draft proposals of legislative acts. He is currently engaged in long-term research projects on the legal challenges of the information society and on the impact of the European regulation of electronic communications and competition law on the legal position of telecommunications networks. Since 2020, he has been a member of the Data Governance Working Group at the Global Partnership on Artificial Intelligence.

Additionally, she participated as a lecturer or participant in scientific conferences and courses at home and abroad (see CROSB). She teaches collegiums Criminal Law (lectures, seminars, etc.), Juvenile Criminal Law and Misdemeanor Law on Integrated Graduate Studies. At the postgraduate level 'Postgraduate Specialist Study in Criminal Law', she teaches the courses of Criminal Law- General Part, Criminal Law - Special Part and Misdemeanor Law, and at the Postgraduate Doctoral Study of Criminal Law, teaches Criminal Law -General Part, Criminal Law -Special Part, Young Persons in Criminal Law, and Misdemeanor Law.
