INFORMATION CLAUSE

In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ L 119, 04.05.2016, p. 1), hereinafter referred to as 'GDPR', the Institute of Justice informs that:

- The controller of personal data within the meaning of Art. 4.7 of the GDPR shall be University of

- 3. Personal data shall be processed by the administrator for the purpose of:
- 1) organising and conducting the 'International Competition for the best essay Right to Privacy', to be held from 1 July to 31 October, 2022 to as part of the project 'Central European Professors' Network', in accordance with Article 6(1)(a) of the GDPR;
- 2) fulfill the obligations incummtent on the administrator under the provisions of the generally applicable, in accordance with Article 6(1)(c) of the GDPR.
- 4. Personal data may be made available to entities authorized to receive them under provisions of law or contract.
- 5. The data will be processed for the period necessary to organise and conduct the 'International Competition for the best essay Right to Privacy', and then until the legal obligation to keep data expires.
- 6. The data subject shall have the right to:
 - (1) access the content of their personal data and request their rectification or erasure in accordance with the principles set out in Articles 15-17 of the GDPR;
 - (2) restrict th
 - (3) e processing of personal data in the cases referred to in Article 18 of the GDPR;
 - (4) transfer their personal data in accordance with the principles set out in Article 20 of the GDPR, i.e. to receive their personal data from the controller in a structured, commonly used and machine-readable format;
 - (5) withdraw consent at any time without affecting the lawfulness of processing based on consent given prior to its withdrawal;
 - (6) lodge a complaint with **profnet@cea.uni-miskolc.hu**
- 7. In order to exercise the rights referred to in Item 6(1-4), contact the controller or the data protection officer using the contact details provided above.
- 8. Providing data is voluntary, but necessary to take part in the conference. The refusal to provide data prevents participation in the 'International Competition: Right to Privacy'.
- 9. The conference is organized using Zoom Video Communication Inc. (Zoom). The communication is encrypted in TLS 256 bit standardize all the way from participant to participant (end to end encryption). Zoom has no access to the content of the communication. The conference is recorded and stored in the EU. Zoom ensures that it has no access to the recordings because the data "at rest" is also encrypted. Zoom sends telemetry data (i.e., where the user is connecting from, how much data they are sending, what commands they are giving to the service) and basic user data (that which the user entered themselves into Zoom when registering for the meeting) to the US.
