

**RECRUITMENT ANNOUNCEMENT**  
**for three members of the research team**  
**"Legal protection of farmers", tasked with analyzing the foreign including**  
**the Hungarian legal system**

State Treasury - Institute of Justice, with registered office in Warsaw (ul. Krakowskie Przedmieście 25, 00-071 Warsaw), represented by the Director of IJ - dr hab. Marcin Wielec, prof. ucz. hereinafter referred to as the "Principal", invites you to submit applications in the competition **for three members of the research team "Legal protection of farmers" within the implementation of the research project "POLISH-HUNGARIAN RESEARCH PLATFORM 2023"**.

**I. Employment Information:**

- 1. Form of Employment:** Contract of mandate with a monthly salary of PLN 10,000 gross (in words: ten thousand PLN gross). The amount of the remuneration of the research team leader will amount to PLN 12 000 gross (in words: twelve thousand PLN gross).  
**Work hours:** up to 60 hours per calendar month, i.e. approximately 1/3 FTE. There must be constant phone and email contact throughout the project.
- 2. Anticipated duration of employment:** 8 months (April 2023 - November 2023)

**II. Terms of reference for member of the research team will include:**

- 1) developing, together with the research team leader, a research concept for the research team, allowing to achieve the main result in the form of a proposal for an appropriate legal framework for more effective protection of farmers in the context of current threats arising from functioning in society, taking into account, among other things, aspects and conditions of the EU Common Agricultural Policy, legal instruments for the protection of farmers, including the welfare of livestock, contemporary legal conditions of the agricultural real estate market and counteracting food waste allowing to achieve the main result in the form of developing a proposal for the Polish legislator the appropriate legal framework (domestic law: criminal law, civil law, administrative law; international public and private law), based on solutions developed in this area inter alia in Hungary. Among other things, the concept must include a clear and precise statement of 1) research objectives (including research questions and hypotheses); 2) the research methods planned to be used; 3) the significance of the planned research for the development of legal science and the situation of society; 4) the roles of individual members of the research team; 5) the planned timelines for achieving each of the anticipated partial deliverables to achieve the research team's main research outcome over the course of the project;
- 2) participating in the work of the research team and conducting own research - the result of the work in the form of a final report needs to be submitted to the Principal no later than October 15, 2023;
- 3) organizing, with the assistance of the Principal, open scientific seminars using a web platform provided by the Principal, at which the current research results of the research team members, resulting from the research concept of the research team referred to in clause 1, will be presented within the following timeframe:
  - a. - seminar I - no later than May 15, 2023,
  - b. - seminar II - no later than June 15, 2023,
  - c. - seminar III - no later than July 15, 2023,
  - d. - seminar IV - no later than August 15, 2023,
  - e. - seminar V - no later than September 15, 2023;
  - f. - seminar VI - no later than October 15, 2023;
- 4) participation in all open scientific seminars referred to in point 2 and presentation at each of them of current research results resulting from the research concept of the research team referred to in clause 1; in the event of objective circumstances preventing the research team member from attending a seminar in person, the researcher shall, prior to the commencement of that seminar, report that absence with an indication of the reasons to the

- research team leader and provide the presentation of the results in the form of a video recording,
- 5) preparation of a report in English on the conducted research during the months of April - July, in a form suitable for publication in a scientific monograph, and submission of this report no later than August 10, 2023. In the report, the researcher shall present the results of its research resulting from the research team's research concept referred to in clause 1. The report should meet the following formal requirements: max. 80 000 characters with spaces, text boxes and footnotes, without the final references; the report should contain *de lege ferenda* postulates for the Polish and international legislator and information on other possibilities of using the research results in legal theory and practice;
  - 6) preparation of a report in English on the conducted research in the months of August - September, in a form that allows it to be published as a scientific article in a collection of scientific papers in English, and submission of this report no later than October 1, 2023. In the report, the researcher shall present the results of its research resulting from the research team's research concept referred to in clause 1. The report should meet the following formal requirements: max. 80 000 characters with spaces, text boxes and footnotes, without the final references; the report should contain *de lege ferenda* postulates for the Polish and international legislator and information on other possibilities of using the research results in legal theory and practice;
  - 7) organization, with the assistance of the Principal and participation in one event promoting the project no later than October 31, 2023. An event promoting the project may take the form of a radio/television/Internet interview, a press article, a press conference, a meeting with students. Other forms of events promoting the project are also acceptable, subject to prior approval by the Principal;
  - 8) organizing, with the assistance of the Principal, an international scientific conference to summarize the results of the research conducted in April - October, by November 30, 2023;
  - 9) participation in an international scientific conference referred to in clause 7 and presentation there of research results resulting from the research concept of the research team referred to in clause 1;
  - 10) preparation of monthly research progress reports;
  - 11) carrying out the instructions of the research team leader;
  - 12) performance of other tasks commissioned by the Principal related to the subject scope of the project.

**The scope of tasks performed by the research team leader will additionally include, among others:**

- 1) managing the work of the research team,
- 2) approving the content of the reports developed by the other members of the research team and submitting to the Principal all reports developed by the other members of the research team,
- 3) monitoring the progress of the research conducted by individual members of the research team and coordinating their work,
- 4) preparing monthly reports on the progress of the research work of the research team,
- 5) obtaining monthly reports on the progress of their research work from all members of the research team,
- 6) participating in monthly online meetings with the Principal.

**III. Essential requirements for a candidate for research team member:**

- 1) academic or professional degree/title,
- 2) participation in at least 1 (one) scientific research project as a leader or contractor,
- 3) publishing at least 1 (one) scientific publication in Hungarian,
- 4) presentation of at least 1 (one) paper at scientific conference in Hungarian;
- 5) international experience, including but not limited to: participation in a scientific project financed by foreign external funds or authorship or co-authorship of at least one scientific publication in English or presentation of at least one paper at a scientific conference in a

foreign language or presentation of at least one paper at an international conference held abroad or commencing a foreign research stay.

**IV. The rules for conducting the competition, including the criteria for evaluating the applications, are set forth in the Order of the Director of the Institute of Justice in Warsaw No. S 020.8.2023 dated March 8, 2023 on the conduct of the international scientific and research project entitled. "POLISH-HUNGARIAN RESEARCH PLATFORM 2023" and conducting competitions for members of research teams.**

**V. Documents required of Candidate for research team member:**

The application should include all the requirements defined in clause III. The following must be specified inter alia:

- 1) year in which the science or professional degree was earned and the unit that conferred the credential,
- 2) information about scientific research projects (name, year completed, role in project, source of funding) in which the Candidate has actively participated,
- 3) full literature details of publications written by the Candidate,
- 4) titles of papers delivered by the Candidate, language of the papers, titles of scientific conferences, information about their status (national/international), organizers, venue and date.

The application should be submitted on the form set forth in Appendix 1. Applications must be accompanied by the Candidate's CV.

**VI. Information on the manner of communication with Candidates and submission of statements and documents:**

All applications, statements, requests, notifications and information may be submitted by the Principal and Candidates in writing or via electronic mailbox (e-mail).

3. Late or incomplete applications will not be considered;
4. The Principal reserves the right to cancel the procedure without giving any reason at any stage of the procedure, as well as to leave the procedure without selecting the Contractor;
5. The Principal may request Candidates to clarify the content of submitted applications and to supplement the requested documents and statements;
6. This announcement does not constitute a commitment by the Principal to enter into a Contract.

## **XI. Information clause**

Pursuant to Article 13 sections 1 and 2 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the EU L 119, 04.05.2016, p. 1, as amended), hereinafter "GDPR", the Institute for Justice informs you that:

3. Personal data is processed by the controller:
